**From I-26 West**

**Charleston:**

From I-26 West towards COLUMBIA, take the I-126 exit, EXIT 108B, on the LEFT toward DOWNTOWN/COLUMBIA. Merge onto US-76 East. Turn RIGHT onto SUMTER ST, just past MAIN ST. 1820 SUMTER ST is on the LEFT.

**Florence:**

From I-20 West, merge onto I-77 S via EXIT 73A toward COLUMBIA. Turn RIGHT onto ELMWOOD AVE/US-76. Turn LEFT onto SUMTER ST. 1820 SUMTER ST is on the LEFT.

**Aiken:**

From I-20 E, merge onto I-26 E/US-76 E via EXIT 64A toward COLUMBIA. Take the I-126 E exit, EXIT 108B, on the LEFT toward DOWNTOWN/COLUMBIA. Merge onto US-76 E. Turn RIGHT onto SUMTER ST, just past MAIN ST. 1820 SUMTER ST is on the LEFT.
